

Billy Bishop Toronto City Airport Master Plan Climate Action

- The first of it's kind in Canada, the Airport Ferry is being retrofitted to all electric with zero air and noise emissions, which will reduce GHG emissions by 530 metric tonnes in 2021.
- Due to high water levels, a Climate Change and Extreme Weather Vulnerability Assessment concluded that the airport's infrastructure is resilient to the current/projected climate effects.
- Collaborated with NAV CANADA to implement a modern aircraft procedure type known as Required Navigation Performance, which has reduced GHG emissions by 973 metric tonnes.
- Studies being undertaken to reduce/mitigate climate impacts include: Ground Noise Impacts & Mitigation, Stormwater & Glycol Containment Review, and an Air Quality Exposure Study.
- Annual Airport Sustainability Report carbon reduction target of 35% below 2015 levels by 2035

Water conservation:

- Central utility plant represents over 50 percent of water usage at SNA
- → Adding an electrochemical water treatment system to cooling water
- This will save a projected 2.5 million gallons annually (15-20 percent reduction)

Energy conservation:

- → 7 MW rated natural gas Central Utility Plant started operation in 2011
- → Adding a 1.9 MW solar system on a parking garage
- → Adding an 8.8 MW lithium ion battery storage system to support optimization

SMF 7.9 MW Solar Facility








YHZ (Halifax) Carbon Management Plan
